The **AAT Accounting Qualification** gives you all the practical, everyday skills you need to be able to build a career in finance. To qualify you need to complete Levels 3 and 4 of the qualification as outlined below. Find out your recommended entry route below or complete the online **AAT Skillcheck** at www.aatskillcheck.org.uk.

Level 2 Certificate
5 modules assessed by computer based exam or project OR Level 2 ABC

School leavers or students with no accounting experience will be advised to start with Level 2.

Level 3 Diploma
7 modules assessed by computer based exam or project

Students with A levels or 6 months relevant work experience will usually start directly at Level 3

Level 4 Diploma
4 core and 2 optional modules (from a choice of 4) assessed by exam or project

Please call or email us for a funding pack if you can answer yes to all the questions below. Please note that funding is not available for the ABC Certificate programme. Students starting at Level 2 under the funded route must study the full Level 2 syllabus.

- ◆ You are aged 16-24
- ◆ You are UK resident and have been living in the UK for the last 3 years
- ◆ You are employed for at least 30 hours per week in a relevant role
- ◆ Your employer is willing to support your studies and pay any top up fees that might be applicable
- ◆ You do not have a degree and are not currently in full time education
