Terms and Conditions

DON'T PASS - DON'T PAY :

- ACCA and CIMA Students who fail their paper based examinations will be refunded the tuition element of the course fee in full, if they have met the following conditions:
 - i. 100% attendance on a taught course, revision course and question day (where applicable) with First Intuition Maidstone
 - ii. Attended the exam in question
 - iii. Paid for the course in full (i.e. this is not available for transferred pass assurance students)
- The payment will be made to the student directly unless the account is settled by another party who requests payment to them.
- Offer is not available where there is an existing agreement between First Intuition Maidstone and the company you work for.
- Offer does not apply to CIMA T4 courses.

Transferred Pass Assurance from another provider :

To qualify the student needs to show evidence that they had met the qualifying conditions for pass assurance with the other provider. For example

- proof of booking a taught and revision course
- proof of course exam marks

Recommend a Friend :
