Please note that if you are usually employer sponsored for FI courses the billing details may default to your Company Details. If you are paying by company card then this can remain the address and the paid invoice will be sent to your employer but if you are paying with your own card please tick the box (highlighted in green) that says "This is a private booking billed to my personal account". The screen will then update to reflect your own personal billing details and email address which you can edit or it will be blank so you can populate these details.

Your exam booking will be confirmed and you will be sent an invoicing confirming payment and a confirmation email with full details of your exam booking and further instructions. The emails may take up to 30 minutes to arrive.

Section 8:

AAT Computer Based Exam Deferral and Refund Policy.

- From 12 January 2024, students will only be allowed to move or request a refund once for each attempt of an exam without any extra charge. This means you can move your exam free of charge once to a date of your choosing or you can request a full refund and rebook at a later date when you are ready to sit.
- Deferred Exams If you cannot attended an exam that you have deferred once already, you
 will forfeit that exam fee and will need to book and pay for your exam again through the
 website.
- Refunded Exams If you receive a full refund for an exam that you can no longer attend, when you rebook this you will not able to defer it or get another refund, so will need to book and pay the full exam fee again through the website.

All requests for the first deferral or a refund must be received no later than 8.30am on the day the exam is due to be sat. Requests received after this time will be non-refundable.

If you have to resit an exam, this will be counted as a new attempt.
