The Programme

Qualification

The entry requirements will be set by the employer and therefore may vary. You will typically need five GCSEs grade 4-9 (old system A*-C).

You may be required to take functional skills Maths and English at level 2, if you do not already hold the equivalent qualification GCSE grade 4-9 (old system A*-C). This will be done prior to the assessment of the apprenticeship.

Job Role

The roles associated with this apprenticeship can be varied but are likely to include:

- Financial Accountant
- Management Accountant
- Tax Accountant
- External/Internal Auditor
- Financial Analyst
- Management Consultant

Progression

On Completion of the Level 7 professional accountant apprenticeship there may be further qualifications to complete in specialist areas such as tax and audit.

Completion of the Level 7 professional accountant apprenticeship may result in credits being awarded towards relevant undergraduate degree programmes and other relevant master's degrees.



End Point Assessment

The end-point assessment is the final showcase of competency for the apprentice across all the knowledge, skills and behaviours defined in the apprenticeship standards.

Synoptic Assessment

A case study exam.
Set by the Assessment Organisation this exam is likely to be part of the associated professional qualification.

Project Report

A project report completed on a relevant topic.
3/4 critical and evaluative skills and behaviours questions with a total word count of no more than 4000 words.

Duration

The duration of the Level 7 Accounting and Taxation Professional Apprenticeship will typically be 36 months.

The minimum duration on programme before an apprentice can take the end-point assessment is 12 months.

Funding Eligibility

From January 2026, government funding for Level 7 apprenticeships will only be available to those ages 16-21, or under 25's who are care leavers or have an Education, Health and Care Plan (EHCP).
