The aim of this qualification is to provide students with advanced bookkeeping skills necessary to work in a bookkeeping role or to progress to a higher level accountancy qualification. This qualification will ensure you understand advanced bookkeeping principles and concepts, preparation of financial statements for sole traders and partnerships and issues around indirect tax (VAT in the UK) in business. The Level 3 Certificate in Bookkeeping is made up of 2 units from the Level 3 Diploma in Accounting and assessed in two end-of-unit assessments (Financial Accounting: Preparing Financial Statements and Tax Processes for Business). Students completing the Advanced Certificate in Bookkeeping can go on to study the full Level 3 Diploma in Accounting if they wish.

When students become qualified with Level 3 Certificate in Bookkeeping, they can apply to become an AAT Bookkeeper. This will consequently allow them to gain professional recognition with the letters AATQB after their name.
