For the March and September exam sittings, only short revision courses are offered. Typically, these are attended by students looking to extend their study period, e.g. a student would attend a Tuition course in March but then leave the revision course until August to sit the exam in September.

Keeping In Touch Sessions

As part of your tuition course, we include 2 Keeping In Touch sessions (KIT) to support you with your studies.

The KIT sessions include 2 evening sessions starting at 6pm per paper, delivered via Microsoft Teams.

These are designed to ensure that students are staying on track with their studies. The sessions provide a forum to ask questions directly to the tutor, re-cap harder areas of the syllabus, pre-revision question practice and look at exam techniques.

Professional Accountant Apprenticeship (Level 7)



Equivalent to a Master's degree level, the Level 7 apprenticeship offers a programme which will develop business leaders of the future. The programme aligns with globally recognised professional accountancy ACCA qualification, as well as providing structured support and guidance for each apprentice's wider development.

The duration of the Level 7 Accounting and Taxation Professional Apprenticeship will typically be 36 months. The minimum duration on programme before an apprentice can take the end-point assessment is 12 months.
